Acceptance of Terms

By participating in the **X-Streamify** “Early Access or Founding Member” program, you agree to these “Terms of Service”.

Eligibility

Participation is limited to individuals who are at least 18 years of age.

Early Access Program

The Early Access program allows users to reserve a Founding Member position before public launch.

Founding Member Spot Reservation

A Founding Member spot is reserved only after successful payment of the required reservation deposit.

\$49 Non-Refundable Deposit

The \$49 reservation payment is non-refundable and secures a Founding Member position subject to these Terms.

Limited Availability

Founding Member participation is limited to the number of spots advertised by **X-Streamify**.

Tier Selection and Pricing

Final tier selection and pricing will be disclosed as part of the Founding Member offer and launch process.

Future Billing Authorization

By making the reservation payment, you authorize **X-Streamify** to charge the remaining balance due for the selected Founding Member tier when the platform launches, subject to prior notification.

Payment Method Requirements

Customers are responsible for maintaining a valid payment method capable of processing future charges.

Payment Failure

If payment of the remaining balance cannot be successfully processed, access may be delayed, denied, canceled, or reassigned at X-Streamify's discretion.
